MESSAGE FROM RON BEILKE

Unfortunately, I cannot be at my <u>OWN</u> meeting this morning.

I called today's "State of the Villages" chat as MY opportunity to discuss not only all the progress our HOA has made, but also to address all the *rumors*, *innuendos*, *half-truths* and *down right lies* being spread throughout our wonderful community like a growing cancer.

This is not the type of HOA I've promoted during my six years as President of both the Master and Jasmine HOA's. I've tried to created a culture of year-round free community events to <u>bring people together</u>. I've made myself available by phone, text and email and now Facebook. And of course I welcome everyone to stop by my patio to talk if you have something on your mind, or maybe just drop by for a drink?

But now we are a community at war! At least with John & Jenn's small group of followers who share no vision for the future, but rather a desire to live in the past. But I get it, you can't win an election by saying how great things are running.

I cannot attend MY own "chat" this morning because the Park's called their own meeting with their own agenda, one not prepared by management, approved by the President or agreed upon by a majority of the Board. It's somehow become the Park's World. They are "the tail trying to wag the dog".
